

#### YARD MAINTENANCE

# **Bid Requirements:**

- The contractor is required to:
  - Possess and maintain appropriate insurance coverage throughout the duration of contract period.
    - The required minimum is \$1,000,000 of Liability Insurance. Proof of Coverage must be on file in the church office.
  - o Furnish all of his/her own lawn care equipment.
  - o Be Responsible and Required to replace any damaged property. 1
  - Oversee all personal employees to ensure safety to persons and property.
  - Acknowledge if performance, attitude, and/or safety is inadequate, this yearly contract extending from January 1<sup>st</sup> to December 31<sup>st</sup> CAN BE NULLIFIED AT ANYTIME THE CHURCH DEEMS NECESSARY.
  - Submit Bid by October 31<sup>st</sup>

### **Description:** A Minimum Standard

# **Yard Cutting**

- 1) The lawn will be cut twice per month during the months of March through October. (or as deemed necessary by the property committee).
- 2) The lawn will be cut once per month during the months of November through February (or as deemed necessary by the property committee).
  - a) If additional cuts are needed, the church will notify the contractor.

# Edging and blowing

- 1) The lawn will be edged along all sidewalks (each cut).
- 2) The sidewalks and parking lots should be blown (each cut).

#### **Weed Trimming**

1) Grass around buildings, signs, flowerbeds, sidewalks, entrance/exit ways, fences, playground, or any objects must be trimmed (each cut).

### Weed Killing

- 1) Weedkiller should be sprayed monthly during the summer months.
- 2) Weedkiller should be sprayed as needed during the rest of the year.

#### Shrubs

1) All shrubbery should be cut twice per year.

- 2) All plant areas should be maintained as needed.
  - a) If additional cutting is needed, the church will notify the contractor.

## Mulch

- 1) Mulch should be maintained throughout the year.
- 2) Mulch should be replaced every March or April.
